GRADUATE AND PROFESSIONAL COURSE WITHDRAWAL PROCESS

- Students who wish to withdraw from a course must consult their Academic/Program Director and are encouraged to discuss the withdrawal with their instructor. To officially withdraw, students must complete and submit the course withdrawal form to the Registrar's Office **before the last day to withdraw**.
 - o Ceasing to attend classes or notifying the instructor does not constitute an official withdrawal.
- Late Withdrawal: To request a late withdrawal, students must consult with their Student Support Specialist or Program Director and submit a completed Academic Petition stating the extenuating circumstances and a letter of support from an advisor, faculty member, or program/academic director to the college's dean's office offering the course for consideration.
 - Late withdrawal petitions must be submitted to the Registrar's Office by the last day of class.
- Student Eligibility: Withdrawing from a course may affect veterans benefits, visa status, or financial aid. Please consult with the appropriate office regarding the implications of withdrawing from a course on your eligibility.
